## CONSENT TO ELECTRONIC DISCLOSURES

These terms and conditions for electronic disclosures provide the procedures that Lack’s may use to provide you electronically all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you from time to time (together “notices”). We and you agree to apply the federal E-Sign Act to the full extent.

**Your Consent and How You May Withdraw My Consent.** You consent to receiving all notices in electronic form. This consent is necessary to apply for a transaction online. You may change your mind, however, and notify us in writing that you want to receive notices only in paper format. If you have registered for online services (such as electronic statements or mobile alerts), you must also de-enroll from each service.
